## Registration Procedures

Registration is not complete, nor can a place in any class be reserved until:

1. All registration forms are filled out completely, signed, and turned into the administrator.
2. A non-refundable registration fee of \$100.00 and the \$45.00 testing fee, must be submitted with the forms.
3. An interview with parents, children, and the school principal must be scheduled when all registration forms are submitted.

(Gen. 2:24; Rom. 7:2; 1 Cor. 7:10; Eph. 5:22-23)
